#### MINUTES OF 1st GOVERNING COUNCIL MEETING HELD ON 22ND APRIL 2019

The meeting started with the Principal welcoming the gathering and thanking the invitees for attending the program. She presented the activities of the institution, staff and students with a Power Point Presentation. The invitees advised and gave suggestions as the presentation was given. The suggestions were given as to inclusions in the presentation and also about the efforts and initiatives to be taken by the institution and also about the alterations and changes that have to be brought about in the institution.

#### The suggestions to improve the college were

- 1. The college management could approach council of other countries like Malaysia, Sri Lanka for recognizing BDS degree of students who have passed out from the college and the degree issued by The Dr MGR Medical University so as to attract overseas students and fill the NRI seats.
- **2.** Consider the guidelines and approach The Dr MGR Medical University or any other university to recognize our experienced staffs as PhD guide.
- **3.** Can approach the University to get recognition for a department or specialty for doing PhD
- **4.** Minimum requirement of 1 PubMed or any Indexed publication every year by every staff.
- 5. If the staffs are not able to publish papers, a questionnaire could be formulated to find out the problems of staff in publications and see how it could be rectified.
- **6.** Dedicated staff for research should be allotted to increase publication for each department and also constitute a team with research Mentors/ Ambassadors etc to help each other in publications.
- 7. Research committee should be responsible for plagiarism check and without approval of the Research committee no publication can be sent for publication in the name of the college. If the study was done in the college, the college name should be published and has to pass through the college Research committee for plagiarism.
- **8.** Management should invest in the software for plagiarism check or find out whether MGR university has its own to utilize

- 9. PG should complete their thesis publication before completion of course
- **10.**Before implementing any new guidelines, make sure they are well planned and understood by the staff and students and should be placed in next governance meeting after that pass a circular to the staffs.
- **11.**Board of studies can be one single meeting for under graduates and separate meetings of every Department for PG and should conduct once every 6 months
- **12.**Same person should not be sent and sponsored from the college for international conference every year.
- **13.**Staff those presented in the international conference should share their experience with other staff with a presentation to encourage other staffs for doing so.
- 14. Promotions could be based on DCI requirements as and when vacancy arises.
- **15.**Increment should be based on the performance (publications, conference presentation, student guidance and administrative performance) of staff.
- **16.** Teacher training program should be made mandatory for each MDS staff. Each new staff should attend lecture classes of other staffs of the same and different department to improve individual presentation skills (minimum 2 lecture from own specialty and **1** lecture from other specialty)
- 17. Auditor suggested outdoor program for staffs.
- **18.**PPT used for lecture class should be unique for each staff , the presentation should meet the minimum required content and the presentation slides should be supervised by HOD
- **19.**Common topics of multiple department should be discussed among themselves and clear demarcation should be made as to which portion of the topic should be covered by each department so as to not confuse the students.
- **20.** To improve students understanding about procedures, it would be preferable to play the video of the procedure in the lab and also avail access to view the video (not give access to download) through intranet facility
- 21. Provide Wifi facility PG students
- **22.**No of CDE programs conducted to be increased (at least one per month). There should not be a reduction in the number of programs from every year.
- 23.Create a team with 2 student member and young staffs for CDE program organizing

- **24.** BLS training is given in the third year, and since it is valid for only 2 years, another training should be given during internship
- 25. Blood donation volunteers data base to be maintained.
- 26. Routine 6 month dental check up for students from 1st year onwards.
- 27. Soft skill training for students regarding CV writing and facing interview
- **28.** Identify Source of funding from outside for research including The TN Dr MGR Medical university, with strong research proposals.
- **29.** Form SAPIC (student academic performance improvement committee) which includes psychologist, counselor. Regular absentees should be asked to counseled.
- **30.** College staffs and functioning should be student centric. Admissions would improve only through word of mouth. The students should be satisfied to recommend the college to others.
- **31.** To improve student admission address parents and students separately (Setup a exhibition to give them clear understanding of dentistry and the facilities in college)
- **32.** Every staff should attend National and International conferences and present papers atleast once a year.
- **33.** The appointments MDS staffs as senior lecturers (14-MDS Staffs in 2017, 7 in 2018 & one in 2019) and one Reader in Periodontology in 2019 and Relieving orders of 3 seniors lecturers and 2 readers in 2017 and 3 senior lecturers in 2018 has been accepted and ratified.
- 34. Every three months student attendance feedback should to be sent to parents
- **35.** To improve students' academic performance keep frequent test and if they fail to clear the test or absent in the exam give them imposition of test questions.
- **36.** Advised to allocate observational hours for 1st year students and assistance hours for 2nd year students in clinical posting
- 37. Advised to allocate 2 hours for sports in a week for students
- **38.** Frequency of conducting academic governance committee meeting based on the need, that has to decided by the management
- **39.** The proposal of incentives for research and publication was approved.
- **40.** Students and patients feedback analysis and students analysis were accepted and approved.

### Suggestions for improving the power point presentation were

- 1. The number of students and staff present and student to staff ratio should be present.
- **2.** Mention in the presentation about sponsorship from the college for conference and publication to staff and students.
- 3. Mention the number of times each of the speakers were invited
- **4.** Mention the criteria and Outcome of academic audit and also specify the action taken such as re audit
- **5.** Mention about the sponsorship given by the college for research and publications.
