FREQUENCY OF MEETING

The committee meets once in every three months on a regular basis, January, April, July and October. Un-scheduled and emergency meetings are called for as and when a need arises by the Chairman/Convener.

MONITORING

- The IBC on a regular basis undertake auditing to oversee the safety measures three times a year in the month of March, August and December.
- Minimum of two members form an audit team. All procedures to be documented in appropriate forms.
- 3. Random auditing as and when required basis.
- Impart training on biosafety procedures three times a year January, May and September.

ENVIRONMENTAL INFECTION CONTROL

A. GENERAL RECOMMENDATIONS

- Follow the manufacturers' instructions for correct use of cleaning and hospital disinfecting products.
- Do not use liquid chemical sterilants/high-level disinfectants for disinfection of environmental surfaces (clinical contact or housekeeping).
- Use PPE, as appropriate, when cleaning and disinfecting environmental surfaces.
 Such equipment might include gloves (e.g., puncture- and chemical-resistant utility), protective clothing (e.g., gown, jacket, or lab coat), and protective eyewear/face shield, and mask.

B. CLINICAL CONTACT SURFACES

- Use surface barriers to protect clinical contact surfaces, particularly those that are difficult to clean (e.g., switches on dental chairs) and change surface barriers between patients.
- Clean and disinfect clinical contact surfaces that are not barrier-protected, by
 using an recommended disinfectant with a low- (i.e., HIV and HBV label claims)
 to intermediate level (i.e., tuberculocidal claim) activity after each patient. Use an
 intermediate-level disinfectant if visibly contaminated with blood (IB).

C. HOUSEKEEPING SURFACES

- Clean housekeeping surfaces (e.g., floors, walls, and sinks) with a detergent and water or disinfectant/detergent on a routine basis, depending on the nature of the surface and type and degree of contamination, and as appropriate, based on the location in the facility, and when visibly soiled.
- Clean mops and cloths after use and allowed to dry before reuse; or use singleuse, disposable mop heads or cloths.
- 3. Prepare fresh disinfecting solutions daily and as instructed by the manufacture.
- Clean walls, blinds, and window curtains in patient-care areas when they are visibly dusty or soiled.

D. SPILLS OF BLOOD AND BODY SUBSTANCES

 Clean spills of blood or Other Potentially Infectious Materials and decontaminate surface with disinfectant with low- (i.e., HBV and HIV label claims) to intermediate-level (i.e., tuberculocidal claim) activity, depending on size of spill and surface porosity.

E. CARPET AND CLOTH FURNISHINGS

 Avoid using carpeting and cloth-upholstered furnishings in dental operatories, laboratories, and instrument processing areas
