MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING IS MADE AND EXECUTED ON
THIS DAY OF 03/06/2025

This memorandum of understanding (MOU) is entered into by and between TAGORE
DENTAL COLLEGE & HOSPITAL AND HILTON MATRICULATION HIGHER
SECONDARY SCHOOL.

Wherein both the partner institution agree on co-operation in promoting and creating
awareness on oral health and enriching student's competencies in educational,
occupational exploration and career planning that would be mutually beneficial towards
common goals and drive towards academic excellence.

I PURPOSE:

The purpose of this MOU is to establish initial agreements towards implementing 'School Adoption program and mechanisms for continuing cooperation between associated school and Tagore dental college to achieve the following objectives.

THE OBJECTIVES OF THE SCHOOL ADOPTION ARE AS FOLLOWS:

- A. To conduct yearly dental inspection for school children of all grade.
- B. To implement referral system for treating oral disease.
- C. To facilitate joyful oral health learning environment.
- D. To involve students in various world health day activities.
- E. To provide career counselling for school children's.
- F. To provide oral health treatment at discounted rate for all teaching and non-teaching staff of the school.
- G. Training program to teachers to handle medical & dental emergencies.

THE MAIN ACTIVITIES TO ACHIEVE EACH OF THE ABOVE OBJECTIVES ARE BRIEFED BELOW.

OBJECTIVE-A: TO CONDUCT YEARLY DENTAL INSPECTION FOR SCHOOL CHILDREN'S OF ALL GRADE.

Every year a dental team containing M.D.S staffs and CRRI students will visit the school and oral screening will be conducted for all school children. Oral health record will be maintained for each individual student and their oral findings will be recorded along with other vital signs.

OBJECTIVE-Bi.e. TO IMPLEMENT REFERRAL SYSTEM FOR TREATING ORAL DISEASES.

After oral screening, students found with any oral problems will be given a referral cards stating their oral condition and treatment plan. Students will be instructed to show those referral cards to their parents and return it to school teachers after getting signature from their parents. If those students return to Tagore dental college & hospital with their parents for treatment, 30% discount will be provided on all treatment cost.

OBJECTIVE-C i.e. TO FACILITATE AND CREATE JOYFUL ORAL HEALTH LEARNING ENVIRONMENT.

The oral health learning levels of school children will be enhanced by conducting various oral health competitions like essay writing, health talk, drawing and debate competition. These competitions will be conducted on specific world health days and prizes will also be distributed for the student's to encourage active participation.

OBJECTIVE-D i.e. TO INVOLVE STUDENTS IN VARIOUS WORLD HEALTH DAY ACTIVITIES.

School children will be given an ample opportunity to take part in various community health programs along with Tagore dental college & hospital to spreading and creating awareness among general public by taking part in various activities like tree plantation, health talk to public, road rally, distribution of pamphlets for spreading awareness during special world health days.

OBJECTIVE-E i.e. TO PROVIDE CAREER COUNSELLING FOR SCHOOL CHILDREN'S.

Once in every year all 10 grade students will be taken to our dental college as a field trip to create awareness about our profession. Tagore dental college and hospital will also take necessary arrangements for conducting career counselling seminar to students of 10 and 12" grade once in a year. This will aid in developing students competencies in self-knowledge, educational and occupational exploration and career planning.

OBJECTIVE-F i.e. TO PROVIDE ORAL HEALTH TREATMENT AT DISCOUNTED RATE FOR ALL TEACHING AND NON-TEACHING OF THE SCHOOL

Tagore dental college and hospital will provide a dental treatment card to all their teaching and non-teaching staffs. College will provide all dental treatment to all their staff and to their family member at a discounted rate of 30 percent for those who visit our college with the dental treatment card provided to them.

OBJECTIVE-G Training program to teachers to handle medical & dental emergencies.

Tagore dental college and hospital will provide training to all school teachers once in a year regarding management of medical and dental emergencies. Thus utilization of teaching professionals for oral health promotion and education can aid as a valuable tool for population-based oral health promotion approaches and the ultimate objective of achieving oral health for all.

II. RESPONSIBILITIES OF THE SCHOOL AND DENTAL COLLEGE

RESPONSIBILITIES OF THE HILTON MATRICULATION HIGHER SECONDARY SCHOOL

1. School to provide a dedicated Team of 2 to 3 teachers who would jointly work with Tagore dental college team for the implementation of the above mentioned activities.
2. School to provide one classroom for conducting oral screening and other educational activities whenever it is undertaken.
3. School to accommodate the program at the mutually convenient time frames.
4. The school will ensure that the parent's consent has been obtained for their children's treatment.
5. The school will ensure that one parent will accompany the children to the college for any treatment visits.

RESPONSIBILITIES OF TAGORE DENTAL COLLEGE

1. To implement the above-mentioned activities in well-organized manner.
2. To provide all dental treatment at 30 percent discounted rate to school students, staffs and staff family member's
3. Jointly finalize dates for the various events with the school team of teachers at mutually convenient time frames

EFFECTIVE DATE

This Memorandum of Understanding is effective upon signature of the two parties.

IV. AMENDMENTS



This Memorandum of Understanding may be notified or amended by written agreement between the **TAGORE DENTAL COLLEGE & HOSPITAL AND HILTON MATRICULATION HIGHER SECONDARY SCHOOL.**

V. DISCLOSURE OF INFORMATION


Subject to the Right to Information Act-2015, decisions or disclosures of formation to the public regarding activities undertaken pursuant to this MOU will be made following consultation between the Tagore dental college & hospital and the School.

VI. DURATION AND TERMINATION

This Memorandum of Understanding shall be effective beginning with the date of the last signature hereon and ending three (3) years after that date, upon the expiration of the Program, or upon mutual agreement of the parties, whichever occurs first.
